Ongoing Business:

- 1. Budget Issues: Trustee Cole advised we are now obligated to use most of our remainin budget for tree removal. Upcoming annual fees will include the insurance bill and the auditor.
- 2. Trees: The tree which fell on the Southeast corner of the property, although on a telephone line, is deemed the Cemetery's responsibility. We have obtained a tree service to remove the tree, which will happen shortly.
- 3. Maintenance: The job was posted for someone to do regular yard maintenance, but without enough funding it will have to approved on a job-to-job basis. Approved: Retaining a tree removal service for the large trees down and; purchase of 4 yards of gravel for the parking area and road repair. Expenditure towards someone to help maintain (specifically weed wack) the center area of the Cemetery, was also approved.
- 4. Endowment Fund Use: Once the cemetery is at capacity, the Trustees will be able to tap the endowment fund for maintenance issues which are ongoing. A formal request to the County for the information on the amount of the endowment fund would give the Trustees a better idea of when best to consider the transition. Approved: Cole will make a formal request to the County re the endowment funds.
- 3. Board Positions for 2022: NK motion/YV 2nd that KC be officially appointed Board Chair. Unanimously approved. YV stepped forward to take over secretarial duties, NK

Hopland Cemetery Board Meeting June 14, 2022 will remain treasurer. There remains one (1) board seat vacant, which unless filled within 90 days someone may be appointed by the Board of Supervisors. KC will file updates with the County.
